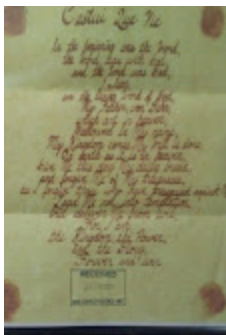

Dear Sir or Madam,

I've been waiting for a reply to this email since the Decision by Marc E. Smith that was unacceptable for FRAUD. Marc E. Smith was CLEARLY advised that all defendants have submit affidavits of FRAUD.

These criminals have been colluding with clerks of three Ontario Superior Courts who have not been requiring service of documents on any of the defendants in the attached Claims.
